Under Section 29, Bid Opening of the 2016 Revised IRR of RA 9184, "In case the bids cannot be opened as scheduled due to justifiable reasons, the BAC shall take custody of the bid submitted and reschedule the opening of bids on the next working day or the soonest possible time through the issuance of Notice of Postponement to be posted in the PhilGEPS Website and the Website of the Procuring Entity concerned".
- 3. In addition, pursuant to Non-Policy Matter (NPM) 122-2013 issued by the Government Procurement and Policy Board (GPPB) the BAC is empowered to postpone and re-schedule the conduct of bidding activities by virtue of a supplemental bid bulletin, to wit:
